### OUR PROGRAMS

### **RESEARCH + ADVOCACY**

Our qualitative and quantitative research initiatives fall into one of three broad program areas: Access to Justice & Civil Courts, Criminal Courts, or Civil Liberties & Police Accountability. Guided by our volunteer-led program advisory committees, our team uses mixed-methods research, evidence-based advocacy, and community engagement opportunities to reduce the harms of the legal system.

Our Court Observation & Education Program (COEP) is our volunteer court-watching program, which helps demystify the judicial process, hold judges accountable, strengthen our research and advocacy, and show solidarity with people navigating the legal system.

#### FUTURE JUSTICE LAWYERS OF CHICAGO

The Future Justice Lawyers of Chicago program is a joint program of Chicago Appleseed Center for Fair Courts and the Chicago Council of Lawyers. The program is for local high school and undergraduate college students who are interested in becoming lawyers dedicated to serving justice in some way. We provide these students with opportunities to engage with the system and our research and to network with lawyers from different backgrounds.

### OUR IMPACT



Since 2022, we have published 12 research reports ranging from the criminalization of gun possession, electronic monitoring, Restorative Justice Community Courts, pretrial fairness and money bond, diversion courts, civil asset forfeiture, police perjury, and prosecutorial trends, to name a few. These reports combined research and advocacy to bring change to the criminal and civil legal system.

Chicago Appleseed Center for Fair Courts staff have published 5 letters to the editor since the beginning of 2022, which have appeared in the *Chicago Tribune* and the *Chicago Sun-Times*. In 2024 alone, we were cited or interviewed for over 20 news articles and have also made several appearances on TV and radio news programs, podcasts, and a *Teen Vogue* video series.





In less than two years, we've trained over 300 community members across Illinois to court-watch. These volunteers have collected more than 3,000 observations in criminal, civil, and domestic violence hearings during that time in order to hold the judiciary accountable and supplement our research.

### 2024 HIGHLIGHTS

#### MAJOR VICTORY REGARDING PRETRIAL ELECTRONIC MONITORING IN COOK COUNTY

On **November 21, 2024**, following budget hearings in which our research was cited many times, the Cook County Board of Commissioners voted to pass a budget amendment that significantly reduced funding for the Cook County Sheriff Office's electronic monitoring program. This puts the county on track to consolidate the two programs into one that's administered by the Office of the Chief Judge instead. Having spent years advocating for reform of pretrial electronic monitoring in Cook County, Chicago Appleseed is thrilled to see this direct result of our sustained advocacy. We will continue to monitor the state of electronic monitoring in Cook County under the Pretrial Fairness Act and advocate for changes that reduce its harms on people's lives.

### **EXPANDING CIVICS EDUCATION**

Our website, VoteForJudges.org, has provided a central hub of information for people electing judges in Cook County since 2010. Historically, the site has reached over 60,000 people every election cycle; during the **November 2024** general election cycle, the site had a whopping 2,000,000 hits with over 100,000 unique individuals using VoteForJudges.org to research judicial candidates.

#### ONE YEAR OF THE PRETRIAL FAIRNESS ACT

On **September 18, 2024**, Chicago Appleseed Center for Fair Courts – with our partners in the Illinois Network for Pretrial Justice – celebrated one year of the Pretrial Fairness Act, the legislation that made Illinois the first state to abolish money bond. We were pivotal in drafting and advocating for the Pretrial Fairness Act which has now made pretrial release the norm and restricted which cases are detentioneligible. Last year, we trained hundreds of people across Illinois to observe pretrial detention hearings and interviewed dozens of public defenders in multiple counties to track the impact of the change.

Our team would like to especially thank our founder, Malcolm Rich, who retired as the Executive Director of Chicago Appleseed Center for Fair Courts and the Chicago Council of Lawyers in March of 2024.

Malcolm founded Chicago Appleseed Center for Fair Courts in 1997 and facilitated our connection to the National Appleseed Network.
